**Directions to Veterinarian:** Leaving the Fair Park, by the main entrance make a right on County Rd PV, go 0.4 miles West, turn left on to ramp for US 45 South, travel 1.4 miles and exit State Rd 60. Make right at bottom of ramp and travel 3.1 miles. Take US 41 north towards Fond du Lac. Exit on to Highway 49 (exit 87). Turn right (east) on County KK. In 1/4 mile, turn right (south) on Columbia Drive to address. Signs will direct you into the parking areas.
