I would like to thank the membership of the Bernese Mountain Dog Club of Southeastern Wisconsin for inviting me to judge your specialty. I would also like to recognize all the people who put the show into action. Your hard work and dedication did not go unnoticed. I would also like to thank all the breeders and their crews for bringing such a great entry of dogs and bitches.

My overall impression of the quality ranged from Good to Exceptional! Proper judging is accomplished when virtues are rewarded and faults minimized. There were some issues, as there usually are. I will ask that breeders pay special attention to front assemblies, proper eye shape and color and although it was only a few cases, bites must not be over looked. Tails continue to be an ongoing battle, that being said I think overall improvements in that area were apparent.

As far as the winners go, they all showed correct type and temperament. The males were all quite masculine and the bitches all very feminine. The icing on the cake for these winners was ideal coats, proper bone and correct movement. I felt the puppies were very promising. This being evident, they were rewarded accordingly.

Firstly I'd like to thank the BMDCSEW for the honor of judging one of your 2019 Specialties. The members and exhibitors were all welcoming and gracious and it was a pleasure to work in your beautiful facility. It is clear you are all passionate about your Berners and I enjoyed the many entries, the sportsmanship displayed by all, and the efficiency of my ring steward.

Overall I was very pleased with the quality of the entries including some very promising youngsters.

For the most part the exhibits were presented in good form, both mentally and physically, with a variety of coat conditions, as I'd expect with this breed at this time of the year. As always, I'm attempting to find the 'complete package', however no dog is perfect, so I need to weigh in the virtues and deficiencies, then reward and forgive accordingly. I would prefer to see and feel more bone in many cases on both sexes, and front ends

could certainly use more 'fill'. I'd like to see improvement in front angles and placement (a problem encountered in many breeds these days) Balance is so important and many entries provided that adequately, but both fronts and rears could benefit from more correct bone lengths and angles in order to produce the required balanced outline I look for in this breed. I did see improvement in tail sets and toplines but noted a few questionable bites and some light eyes. For the most part I

saw purposeful and sufficient gait when exhibits were moved at the appropriate speed.

We all want to see this breed thrive and be our companions for more than a few years. I wish you all continued success in your efforts to accomplish this. Thank You for another wonderful experience with BMD's and the people they keep. Janet Lobb

Dog Owners vs. Cat Owners Happiness

Dog owners were much happier than cat owners in the respected General Social Survey for 2018, the WashPost's Christopher Ingram reports:

- "Dog owners are about twice as likely as cat owners to say they're very happy, with people owning both falling somewhere in between."
- "Dog people ... are slightly happier than those without any pets. Those in the cat camp ... are significantly less happy than the pet-less."
- Why it matters ... "These differences are quite large: The happiness divide between dog and cat owners is bigger than the one between people who identify as middle and upper class."

There's a catch: "Correlation doesn't equal causation, and there are probably a number of other differences between dog and cat owners that account for some of the differences."

"The General Social Survey data show that dog owners, for instance, are more likely to be married and own their own homes than cat owners, both factors known to affect happiness and life satisfaction."

The survey found 6 in 10 households have at least one pet.

The Most Horrifyingly Impressive Things Dogs Have Eaten

The folks at <u>Veterinary Practice News</u> asked vet clinics to send the craziest pet x-rays they have taken via a enter the "They Ate WHAT?" contest. I don't have room for the x-ray photos; but the following are some of the descriptions.

- ♦ A Chocolate lab pup swallowed a six-inch corn-dog stick.
- Five rubber ducks plus two toy parts. The owner had been wondering why her toddlers' ducks were disappearing.
- When an owner realized that one of two shish-kabob skewers of meat and veggies were missing from the kitchen table, she took he dog to the vet. The doctor thought there was no way a dog could swallow a 12 inch skewer, but to his surprise, there it was on the x-ray.
- A 3-year-old Great Dane was taken to the vet after he started vomiting. X-rays showed a large amount of foreign material in the pup's stomach. Exploratory surgery removed 43 socks.
- Colby, a 10month-old Golden Retriever, started vomiting and kept throwing up for nearly two days. The vet discovered the pup had eaten an entire



intact light bulb. After a day of intravenous fluids, Colby passed the light bulb intact.

- ◆ A 7.5-week-old puppy named Elvis went with his owners on a fishing trip. Apparently, the chicken liver bait was enough to entice the pup to try it out hook and all. The hook had perforated the stomach, but thanks to timely surgery and antibiotics, Elvis made a full recovery.
- A 9-pound Chihuahua had 9 sewing needles removed from all over the body. Presumably, the pup ate a box of sewing needles, then the needles migrated throughout his body. The dog required a ventral abdominal exploratory and a ventral sternotomy. He is now needle-free.
- A 12-year-old Welsh Corgi ate nearly 2 cups of pea gravel from a turtle tank.
- ♦ A two-year-old Pug named Stella was brought to the vet after she continuously vomited one night. During an abdominal exploratory, one quarter and 104 pennies were found in the pup's stomach.
- ♦ A Lab was brought in to the vet's office after she swallowed a pocket knife. The vet fed her a small meal and administered Apomorphine, which induced a vomiting episode that expelled the 9.2 by 2.3 cm knife.
- ♦ A 15-month-old Golden Retriever puppy was suspected of eating a missing Hacky Sack. Radiographs gave a clear picture of the intact Hacky Sack inside the puppy's stomach. Apomorphine was administered and the dog vomited out the intact Hacky Sack.

Traveling with your pet? - Know the respective state laws.

Many people traveling inter-state with their dog or cat. Do you know that each state has specific rules for bringing that pet into / through their respective state. For example: the basic requirements for pet dogs or cats to enter Florida are:

- All dogs and cats 3 months of age and older transported into Florida must have a current rabies vaccination. Adequate proof of current vaccination must be from a licensed veterinarian.
- All dogs and cats must have a health certificate issued by a licensed and accredited veterinarian in the state of origin, dated within 30 days of entry, stating that the dog or cat:
- Is free from signs of any infectious or communicable disease,
- Did not originate within an area under quarantine for rabies, and
- Is not known to have a history of exposure to a rabies-infected animal prior to importation.
- For dogs and cats entering Florida to be sold, you must also comply with Florida's Pet Law (Florida Statute 828.29).

Health certificates are not required for:

- Dogs or cats imported for exhibition purposes only, and that will remain in the state less than six months, or
- Any service animal or working dog.


